S.R.O. 127(KE)/2017 :

In exercise of the powers conferred by Section 8 of the Cigarettes (Printing of Warning) Ordinance, 1979 (LXXIII of 1979), the Federal Government is pleased to direct that the following further amendments shall be made in the Cigarettes (Printing of Warning) Rules, 2009, namely :-

In the said Rules, for rule 6, the following shall be substituted namely :-

"6 **Size.-** (1) The Health warning shall cover at least fifty percent of the front side and fifty percent of the back side of cigarette packets and printed cigarette outers from the 1st day of June, 2018.

(2) The Health warning shall cover at least sixty percent of the front side and sixty percent of the back side of cigarette packets and printed cigarette outers from the 1st day of June, 2019.”

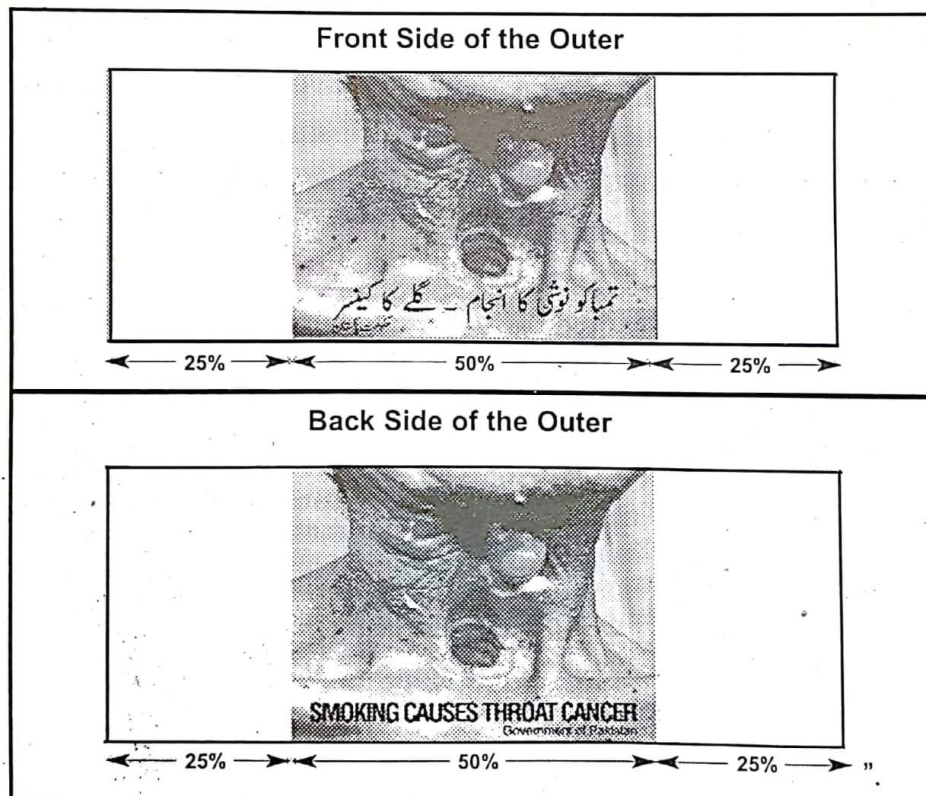
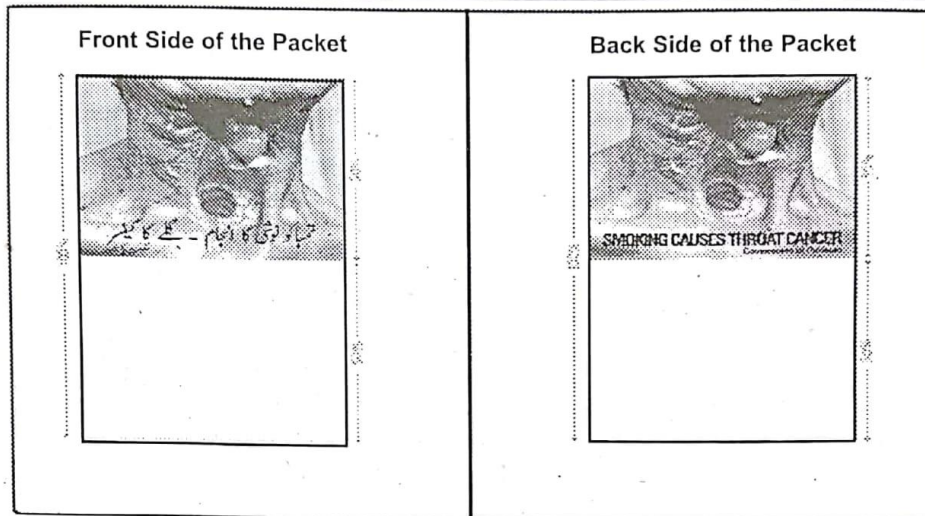
